September 21 and 22, 1966

BUKEAU OF ENTOMOLOGY

Moved by Clyde Smith, seconded by Don Myers, that Robert Du Chanois prepare a brief history from the minutes and notes on what has transpired at each meeting the past seven years as soon as he can get it prepared and mail it to all States who have Pest Control laws. Passed unanimously.

Clyde Smith volunteered to make an analysis of the minimum standards of each state and submit it at the next meeting.

Moved by Robert Du Chanois, seconded by Clyde Smith, that the topic of permissible pesticide usage by the Pest Control industry be placed on the agenda for discussion at the next meeting. Passed unanimously.

Moved by Robert Du Chanois, seconded by Joe Ray, that the States of Georgia and North Carolina and all other states who may be able to contribute information prepare a progress report on soil sampling of chemical treating for subterranean termites and present it at the next meeting. Passed unanimously.

Joe Ray volunteered to correspond with each state to obtain information on the method of financing the Act in each state and put it in chart form. Moved by Mr. Ray, seconded by Robert Du Chanois that same be place on the agenda for the next meeting.

It was agreed that the next meeting be tentatively set for September, 1967, in Little Rock, Arkansas, to run for two days. In the event that Arkansas cannot host the meeting, it was agreed that the second choice would be Georgia. Clyde Smith stated that if neither Arkansas nor Georgia could host the meeting, North Carolina would. It was also agreed that the next Chairman contact each state advising them to come prepared to discuss the feasability of reciprocity of licenses or how far each state was willing to go and the exchange of examination materials.

Moved by Clyde Smith, seconded by Robert Du Chanois that attendance at the State Pest Control Regulatory Officials Meeting be limited to members of the Structural Pest Commissions and/or Boards plus one industry man by invitation from that State. Passed unanimously.

Meeting adjourned at 1:00 p.m. September 22, 1966.

REPORT OF STRUCTURAL PEST CONTROL REGULATORY OFFICIALS MEETING

BUREAU OF ENTOMOLOGY

Although it was disappointing that the majority of the members of the group were unable to attend, it was nevertheless a worthwhile meeting. Those who did attend expressed their appreciation not only for an informative meeting but also because it appears that this meeting put the organization "back on the track" to work toward the objectives for which the group was originally founded.

Ed Bushing gave a very fine talk on his subject and Stennett
Heaton with his presentation of "Words and Pictures" and his running
commentary thereon made a deep impression on the members from other states.
This presentation showed conditions (sometimes evidence of trouble)—then
the exposed damage and the completed job. On the afternoon of the first
day, shortly after 3:00, Sten Heaton presented his "Art in Nature" and all
present were not only greatly impressed by the results of the microphotography as to certain functional parts of the insects but also by the
beauty of the design and color existing in this form of animal life.

The social hour, hosted by Neil A. Maclean Co. Inc., was a distinct success.

On the morning of the second day Ronald W. Hunt, Sr., showed and explained two of the houses used in our examinations, with instructions and forms and all present were extremely favorably impressed.
