Dear Dr. Scott:

I wrote to you in December concerning your interest in Dr. Susan Jones and her research. At that time, we did not know if we would have enough funds in FY 92 to keep her employed full time. We have received the final allocations and we will be able to employ Dr. Jones in a full-time position, located in Tucson, Arizona. Because of the way the money was allocated, she will spend one-half time on termite research in the southwest and the other half on termite ecology work in Puerto Rico. While the latter work is not on control, it will increase the overall knowledge of termites.

At your request, I am advising you that the FY 93 President's budget submitted to Congress contains a cut of \$218,000 in Dr. Mauldin's unit that would seriously affect both Gulfport and Tucson locations. A cut of this magnitude would close research on the use of chemicals from termite-resistant woods and would close research on the use of baiting systems for control of subterranean termites. It would also very likely result in the termination of one scientist.

We appreciate your offer of support for our research effort. I will be in contact with you to provide further details, or you may contact me at 504-589-3003.

Please reference our telephone conversation last Thursday July 23, 1992, regarding the request presented to you by the National Pest Control Association (NPCA). This request focused on a proposed change to have the labeling for termiticide products amended to only require the soil adjacent to the outer foundation walls treated to a maximum depth of four (4) ft. This would only involve the soil immediately adjacent to the outer foundation wall where there is a basement in the structure or a sloping grade with extensive back fill.

First, I would categorically state that there may be circumstances where the Pest Control Operator (PCO) could encounter a structural problem which would prohibit the full label rate application of a termiticide to this type of structure. It is not our intent to require the PCO to exacerbate the structural flaw during the termite treatment. Additionally, if the owner of the property requests a less than labeled volume application, for any reason, it is incumbent upon us to allow that to occur. In these situations, clearly the PCO should be allowed to make the owner aware of the difficulty in treating at the full label rate and have the owner authorize the less than label rate application. Otherwise, the owner will not be aware that they are getting an incomplete treatment.

Second, I have drawn upon the expertise of the scientific and regulatory community regarding the wisdom in limiting these outer wall treatments to a depth of 4ft. The consistent response is that there is no scientific reason to limit the depth of treatment. If the termites are present they will simply forage around the bottom of the barrier and eventually infest the structure.

Third, controlling termites, through the use of pesticides, is a function of placing the termiticide in the proper place and in the proper quantity to create a barrier which will prevent the termites from gaining access. The proper quantity is a function of the proper amount of active ingredient in a mixture and delivered in sufficient amounts to treat the soil completely to the top of the footing. It appears that the primary reason for this request is to sanction the methods currently employed when treating these types of structures. This is the same as saying that because people exceed the posted speed limit on our highways, we should then increase that speed limit to accommodate those who are guilty of speeding.

I would like to go on record with your agency as stating that the Association Of Structural Pest Control Regulatory Officials (ASPCRO), does not believe these label changes should be allowed, which would limit the depth of soil treatment on outer foundations to a maximum depth of 4ft. We strongly feel that these changes are not based upon sound science and do not represent the best interest of the public or the user community. I am convinced you will give this position a great deal of consideration, as you make your decision.
